Requirements for Participation

Participation in the BGCLPC-Durango School District 9-R Transport program is limited and **based on an application process**. To be eligible, the student must meet the following criteria:

1. Must have a current membership to the Boys & Girls Club of La Plata County
2. Must renew membership annually to stay active
3. Must commit to utilize the transportation to the Club **2 or more** times a week.
4. Based on available space, priority will be given to Club members currently in 4th through 8th grade and also consider previous Club participation.
5. We reserve the right to dismiss any member from this service based on behavior issues at the Club or during transport.

If at any point, the Club member does not meet the criteria, their spot will be released to a member on the transportation waiting list.

Deadlines for Applications/ Notification of Acceptance

Applications are **due a week before** wishing to start bus transportation. Notification of acceptance to the program will be given on Thursdays for a start date of Monday. All Club members who are not immediately accepted into this program will be placed on our transportation waiting list and additional participants will be accepted as space allows.

Club Closings

It is the parent/guardian responsibility to make arrangements to ensure that their member(s) are picked up from school on days BGCLPC is closed. Please check the monthly schedule as well as updates that are posted at bgclaplata.org. Please note, that if school is cancelled or dismissed early due to weather, plague or any other disaster, the Club is also closed.

Bus Behavior and Discipline

The buses used for transportation are owned and operated by Durango School District 9-R. All Durango 9-R Transportation rules apply regarding guidance and discipline. Please contact the Transportation Department with any questions.
